State of Wisconsin Higher Educational Aid Board

The series of exhibits present the 2008-2009 academic year student financial aid information for Wisconsin resident undergraduates. The colleges and universities within the four different Wisconsin higher education sectors provided the majority of the information reflected in these exhibits. Data was collected by HEAB through the annual Wisconsin Student Support Information System (WISSIS) survey, which is authorized by section HEA 1.02 of the State Administrative Code. Each institution reported to their respective higher education sectors: the Independent Colleges and Universities (WAICU), the Tribal Colleges, the University of Wisconsin System (UWSA), and the Wisconsin Technical College System (WTCS). Compiled data was provided to HEAB by each sector.

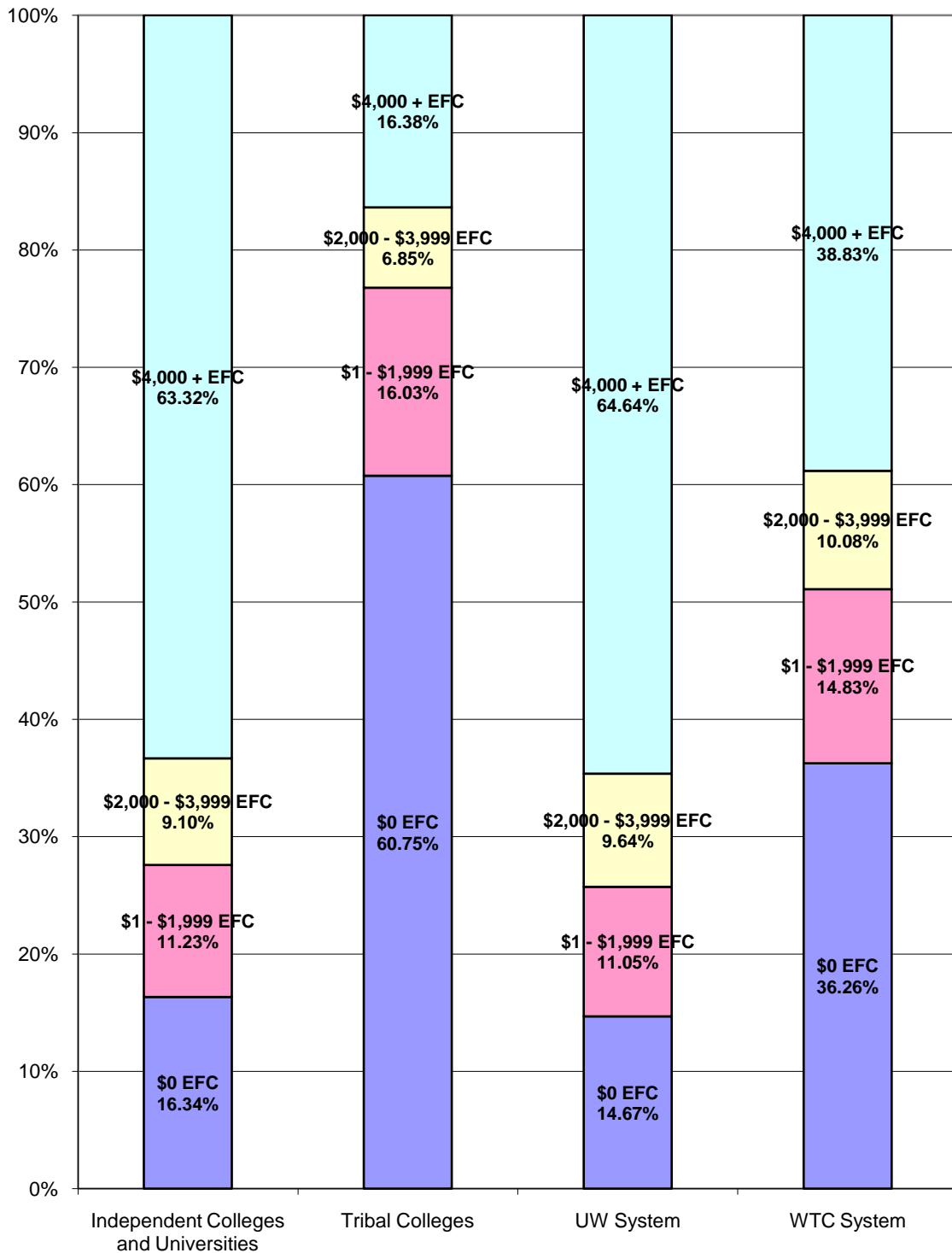

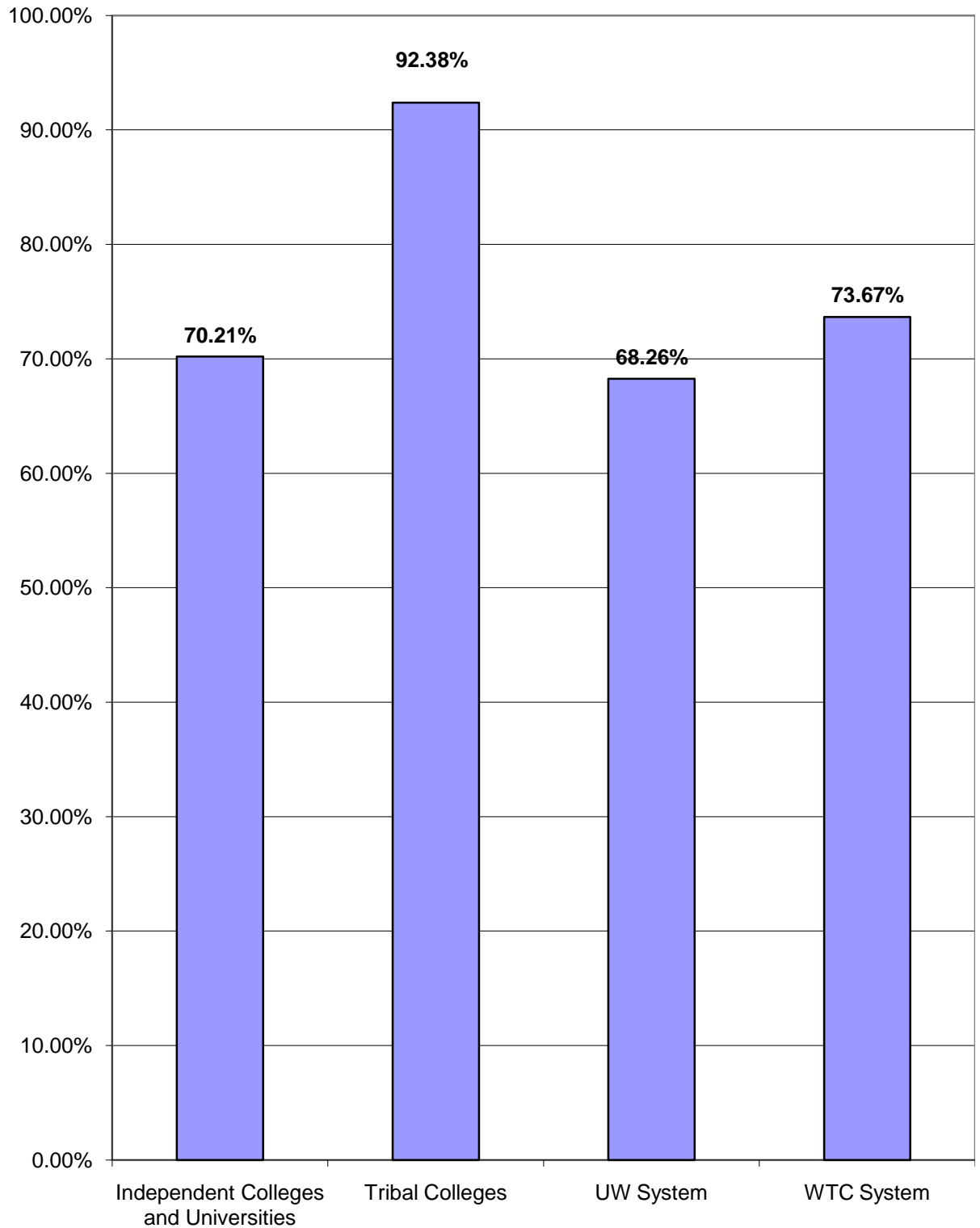
2008-09 FAFSA Applicants Expected Family Contribution (EFC) Comparison



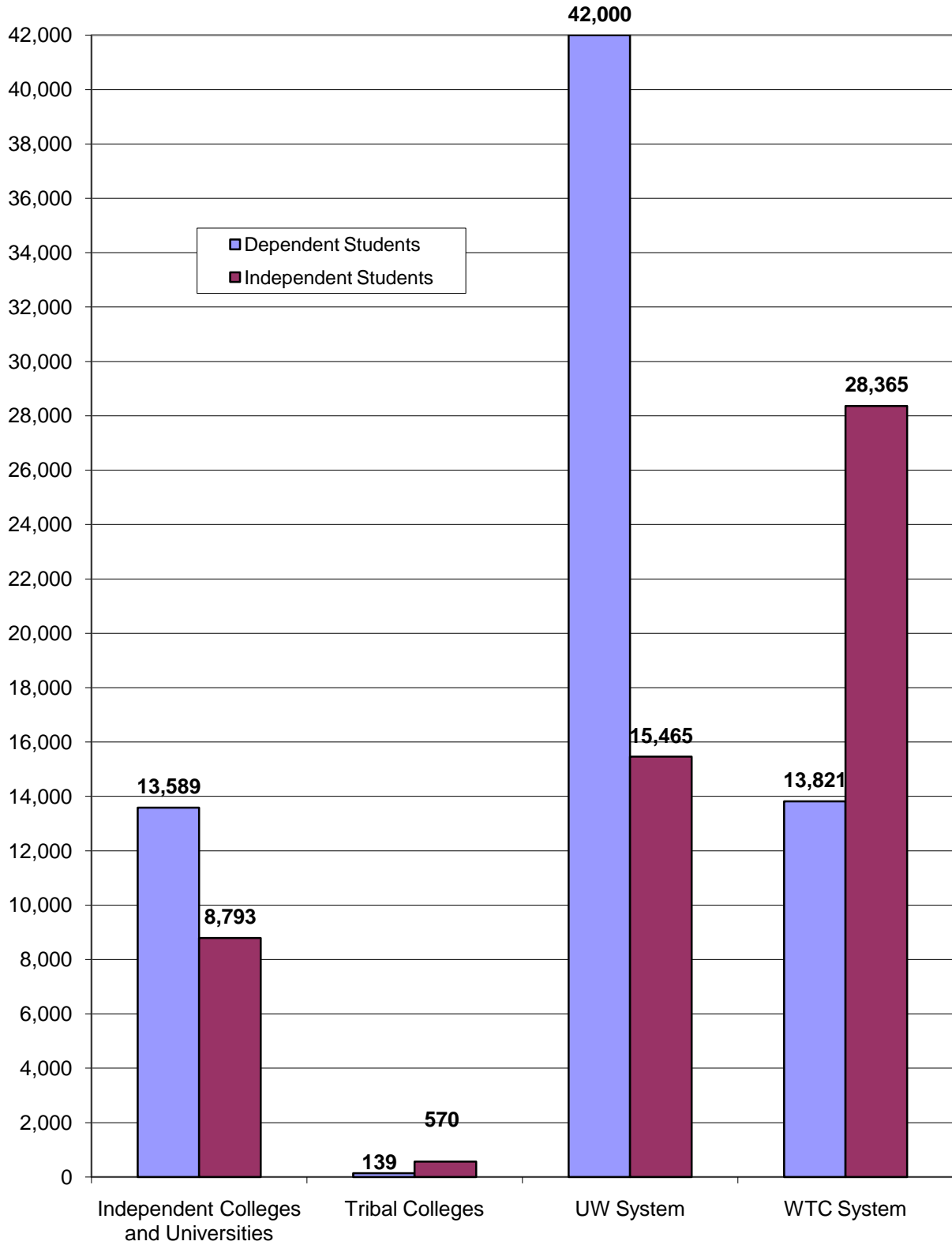

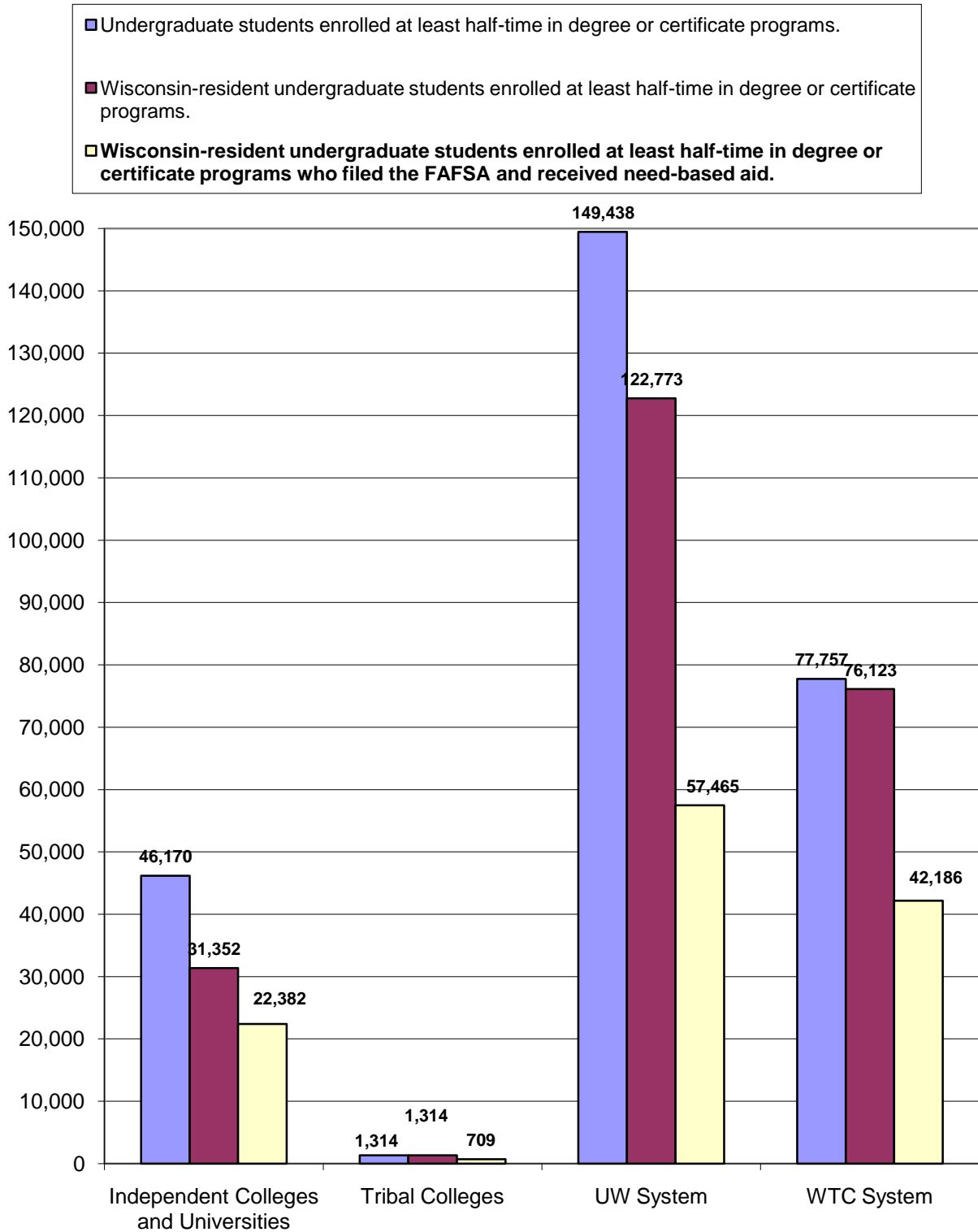

the Expected Family Contribution (EFC)**

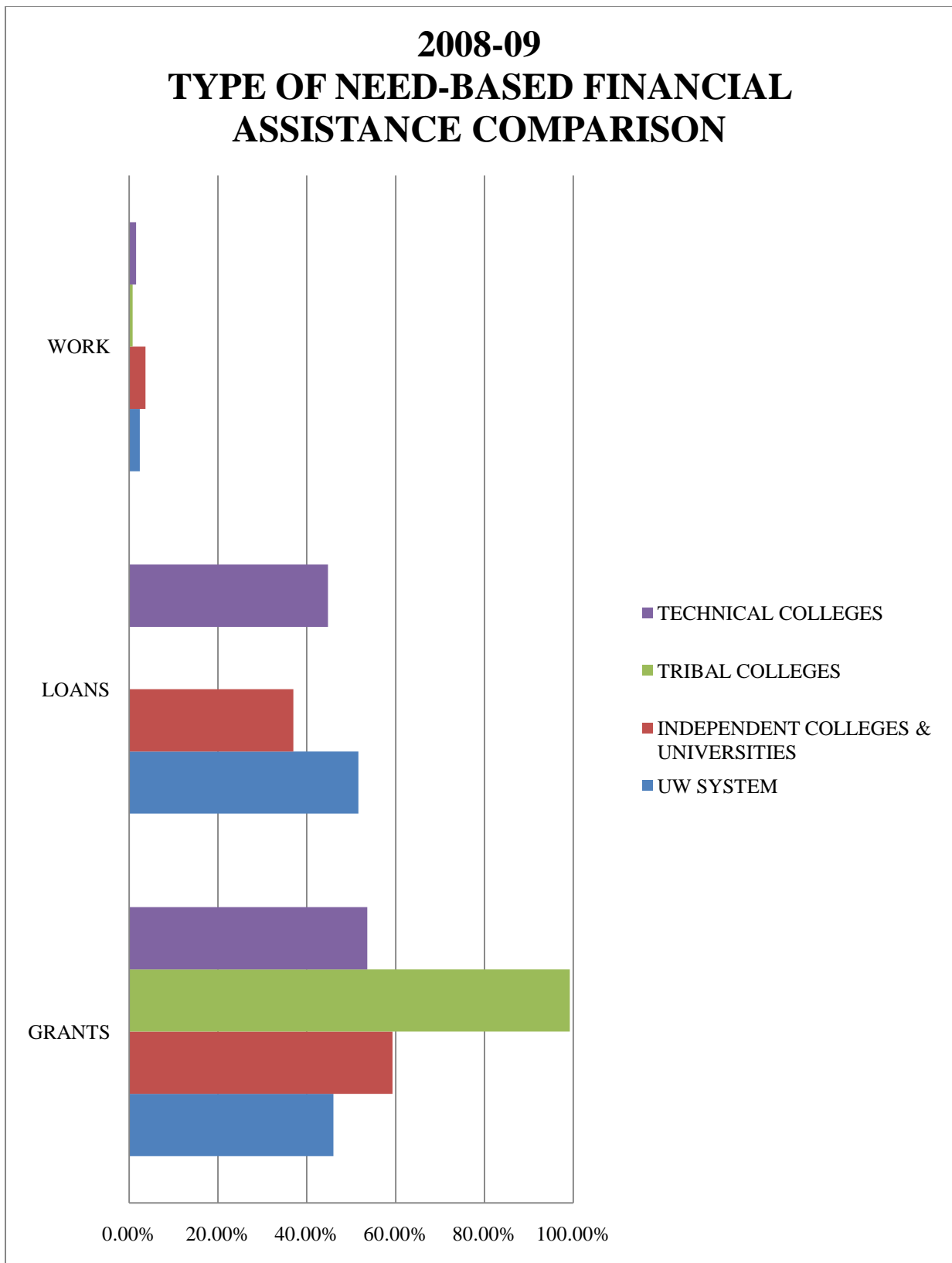

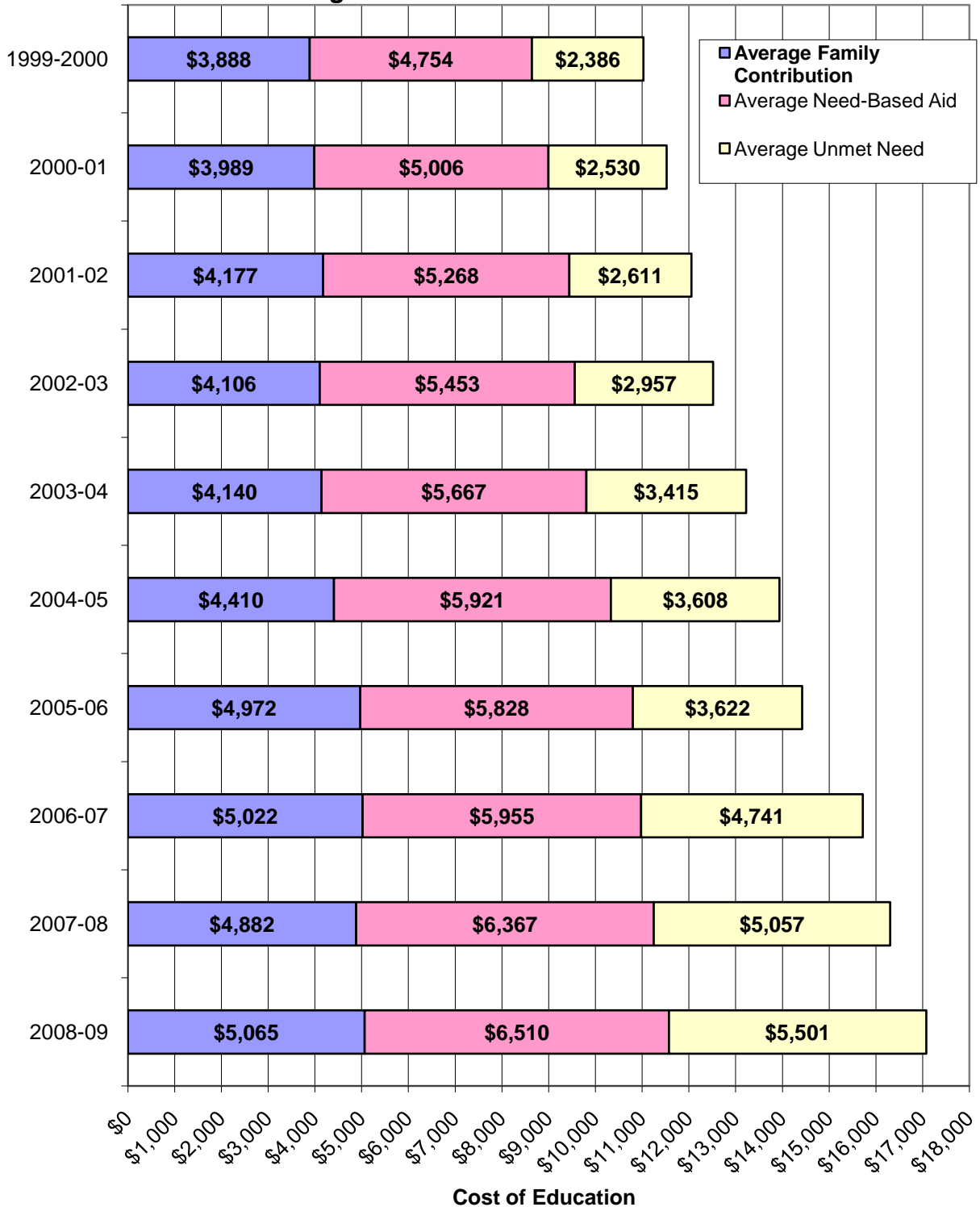

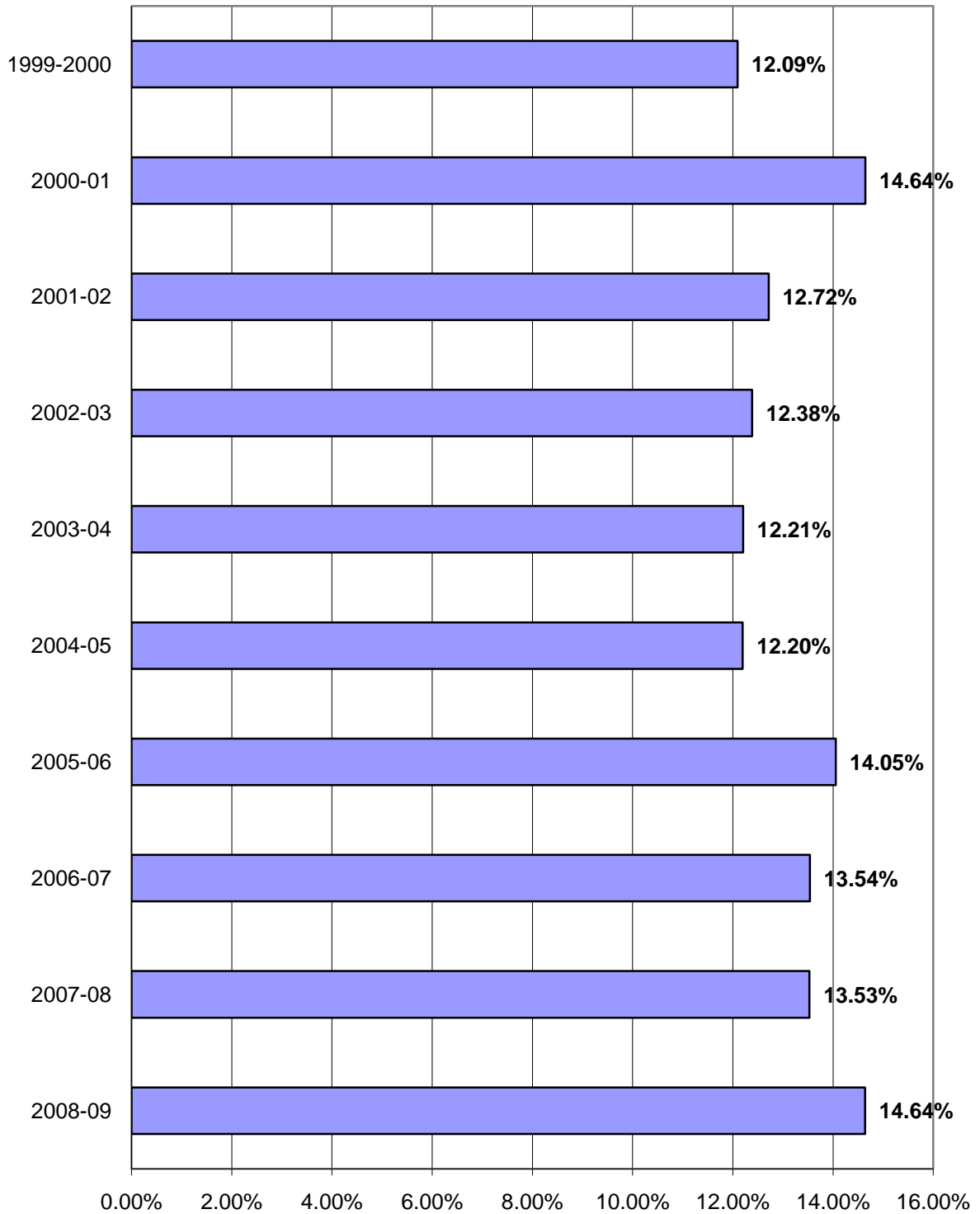

10-Year Average Cost of Education and Unmet Need



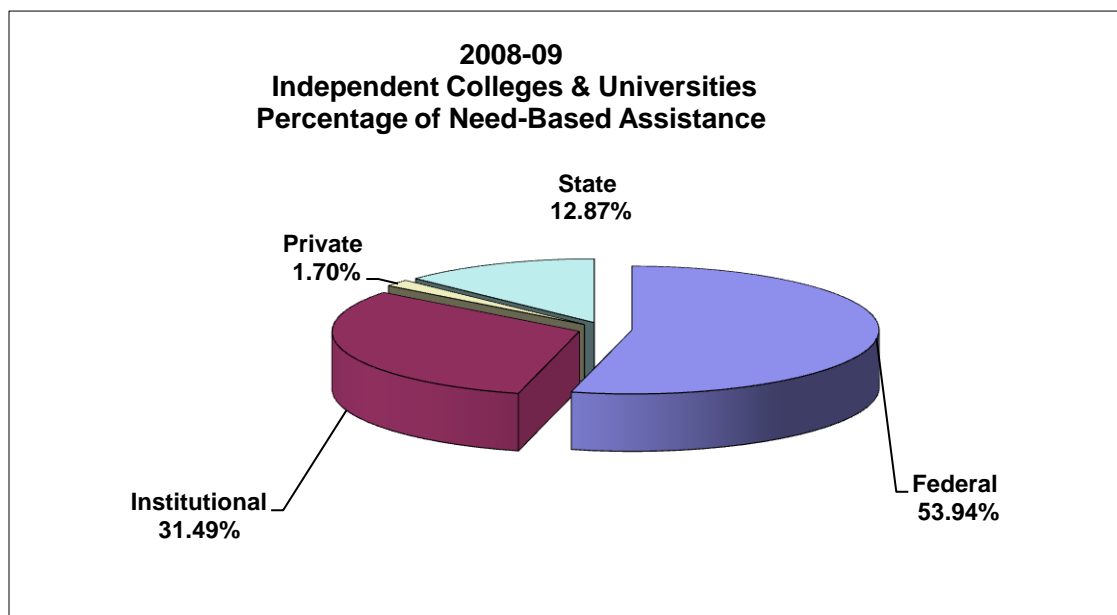

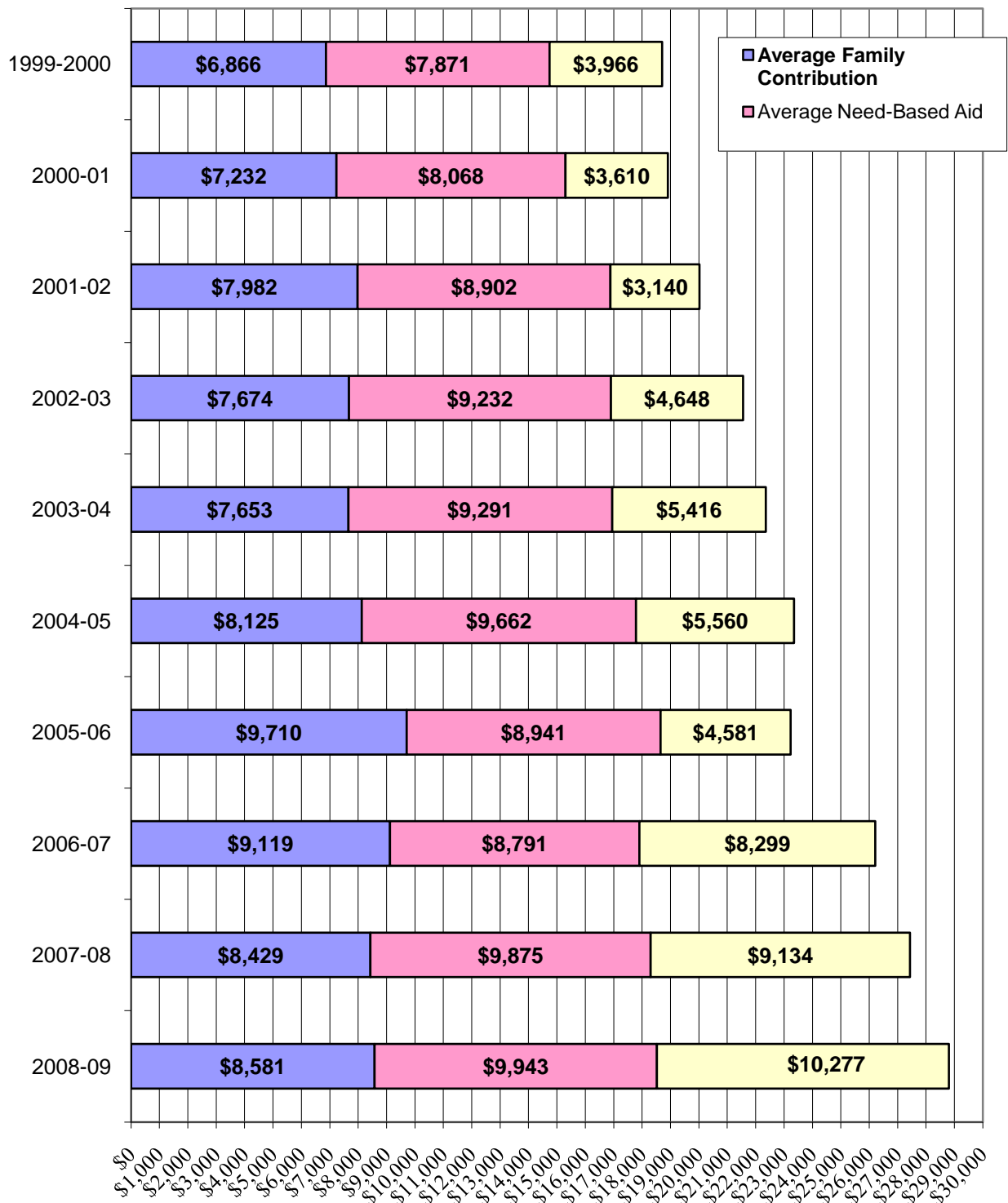

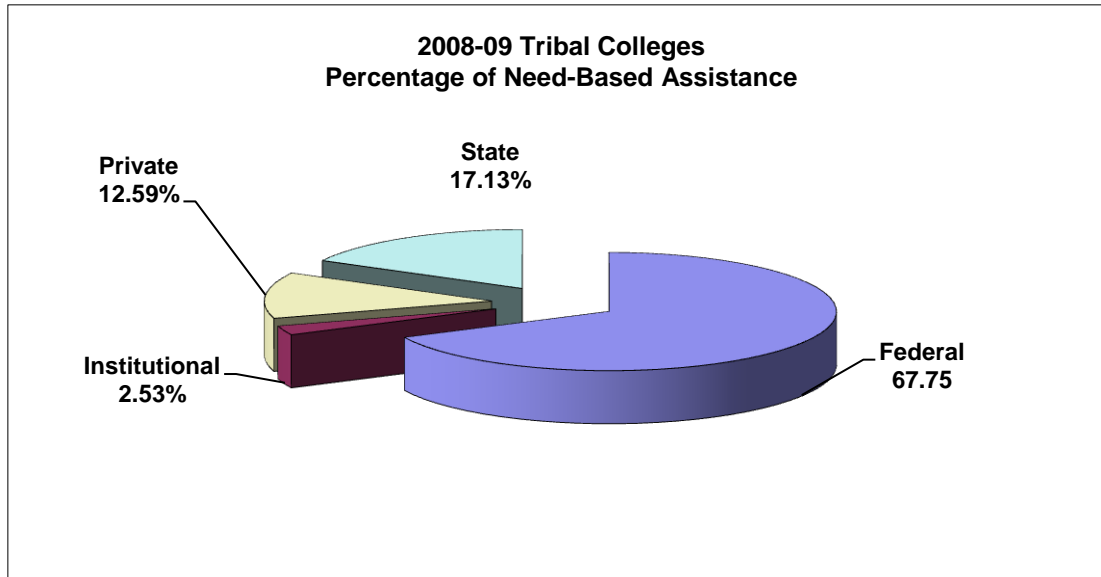

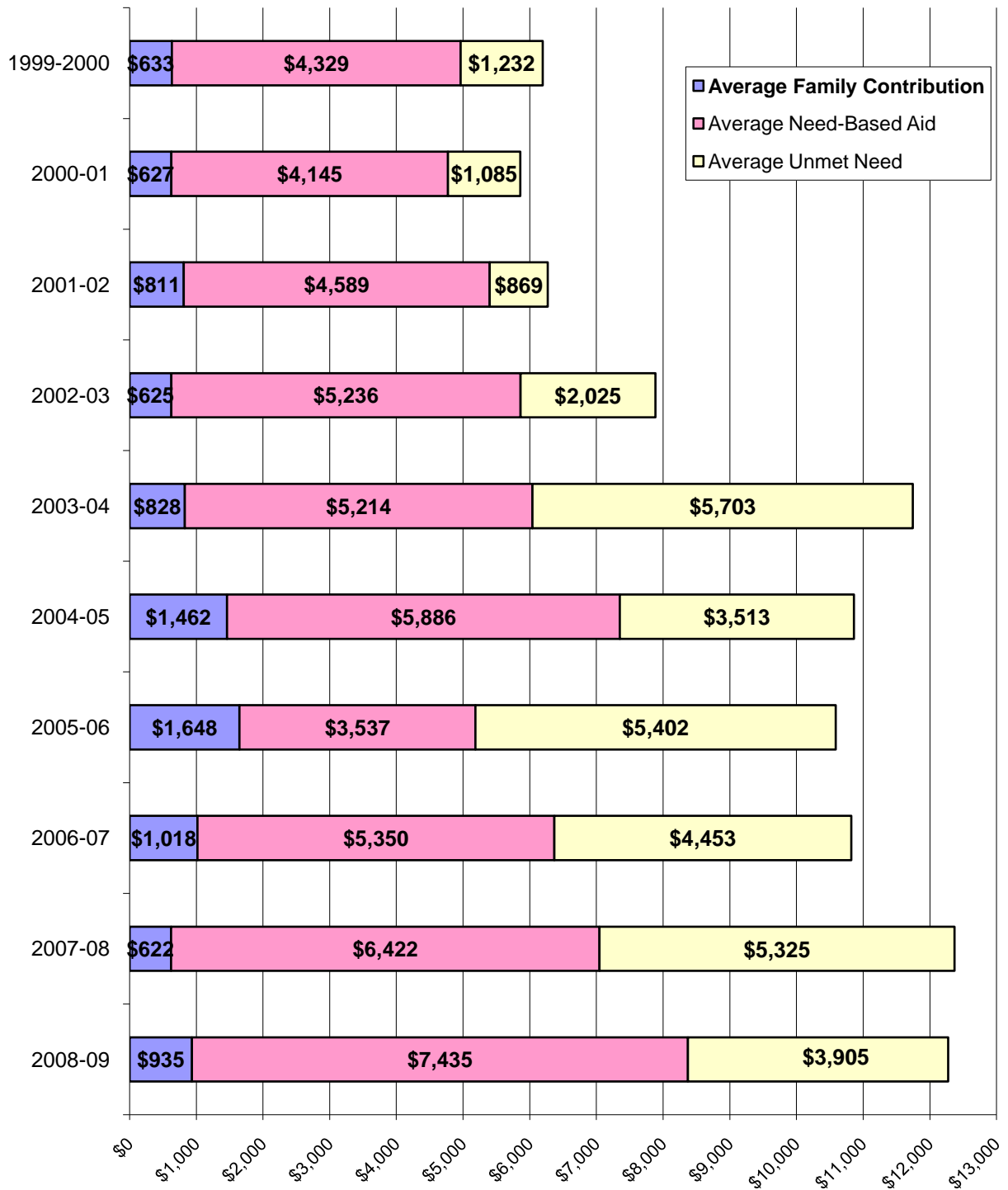

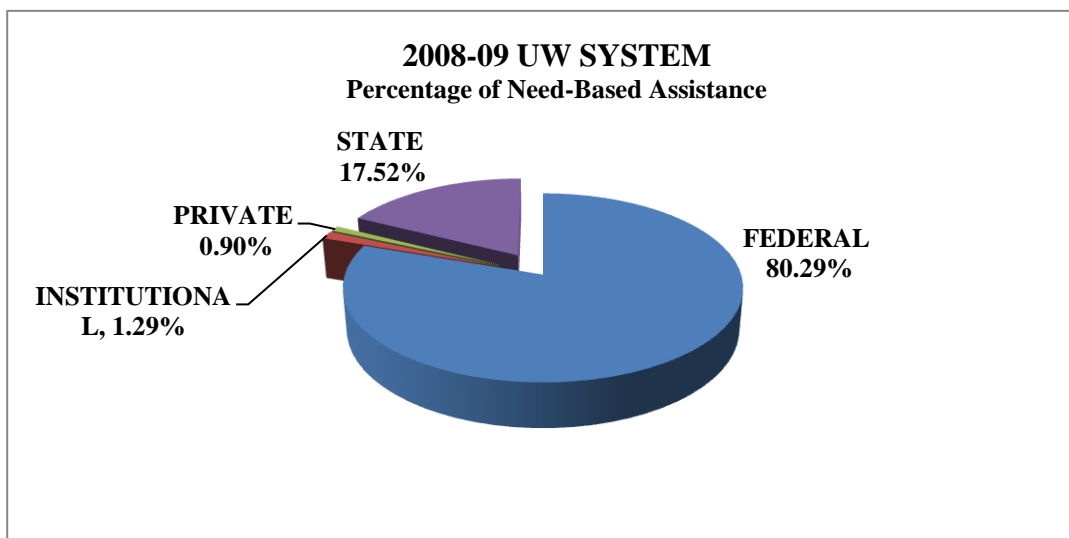

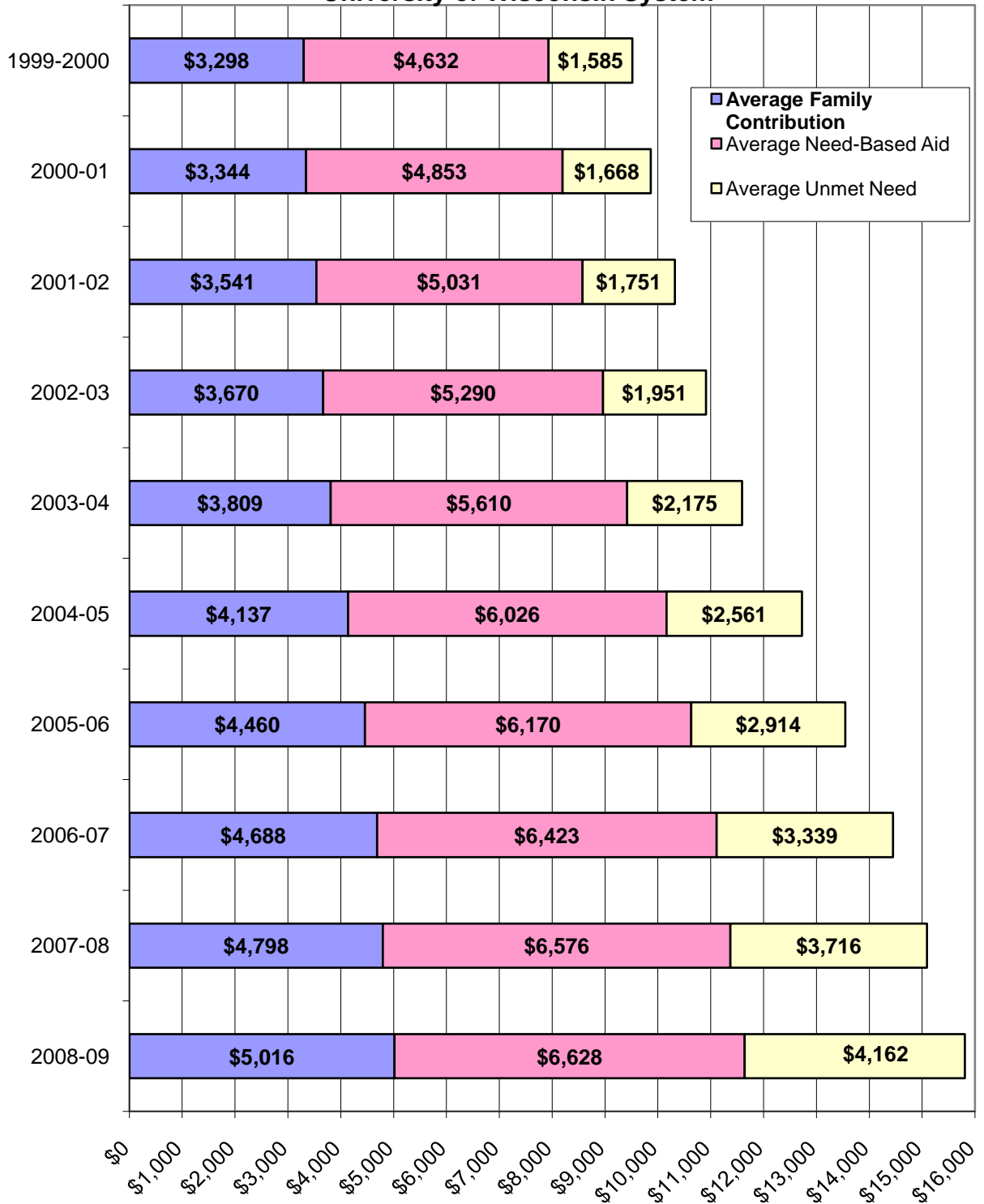

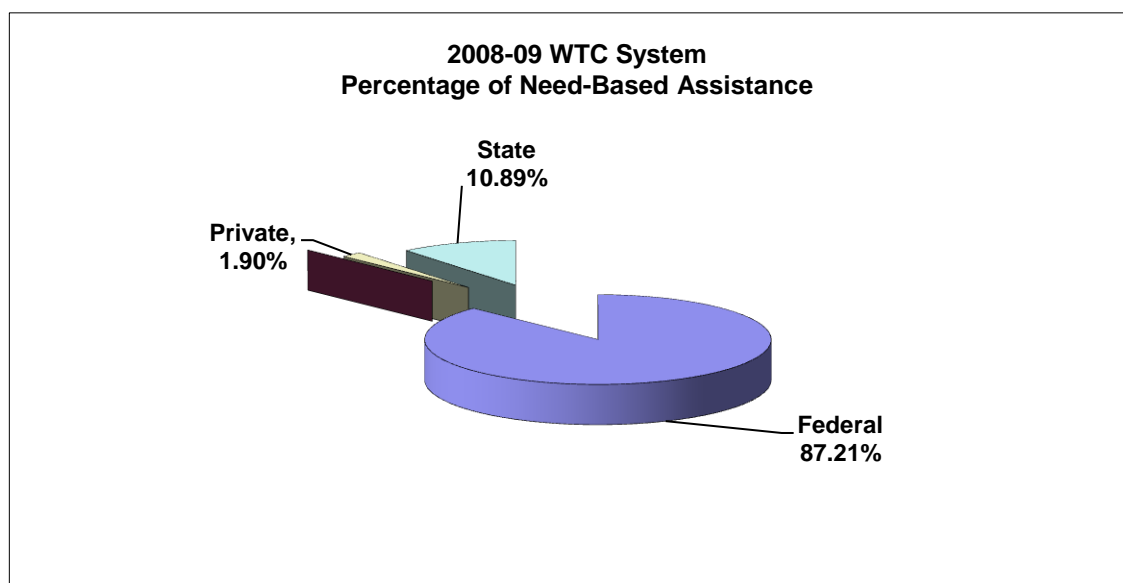

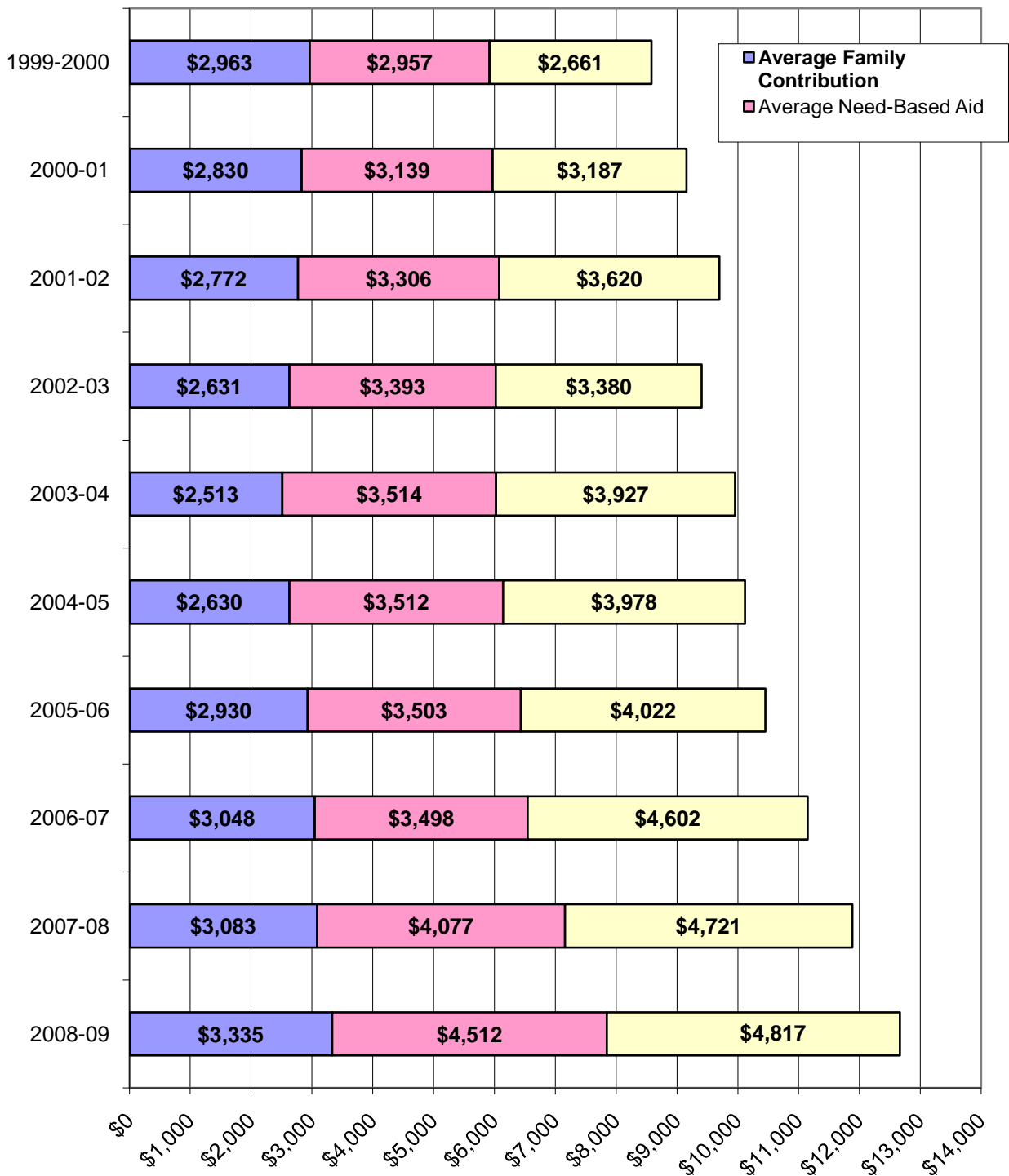

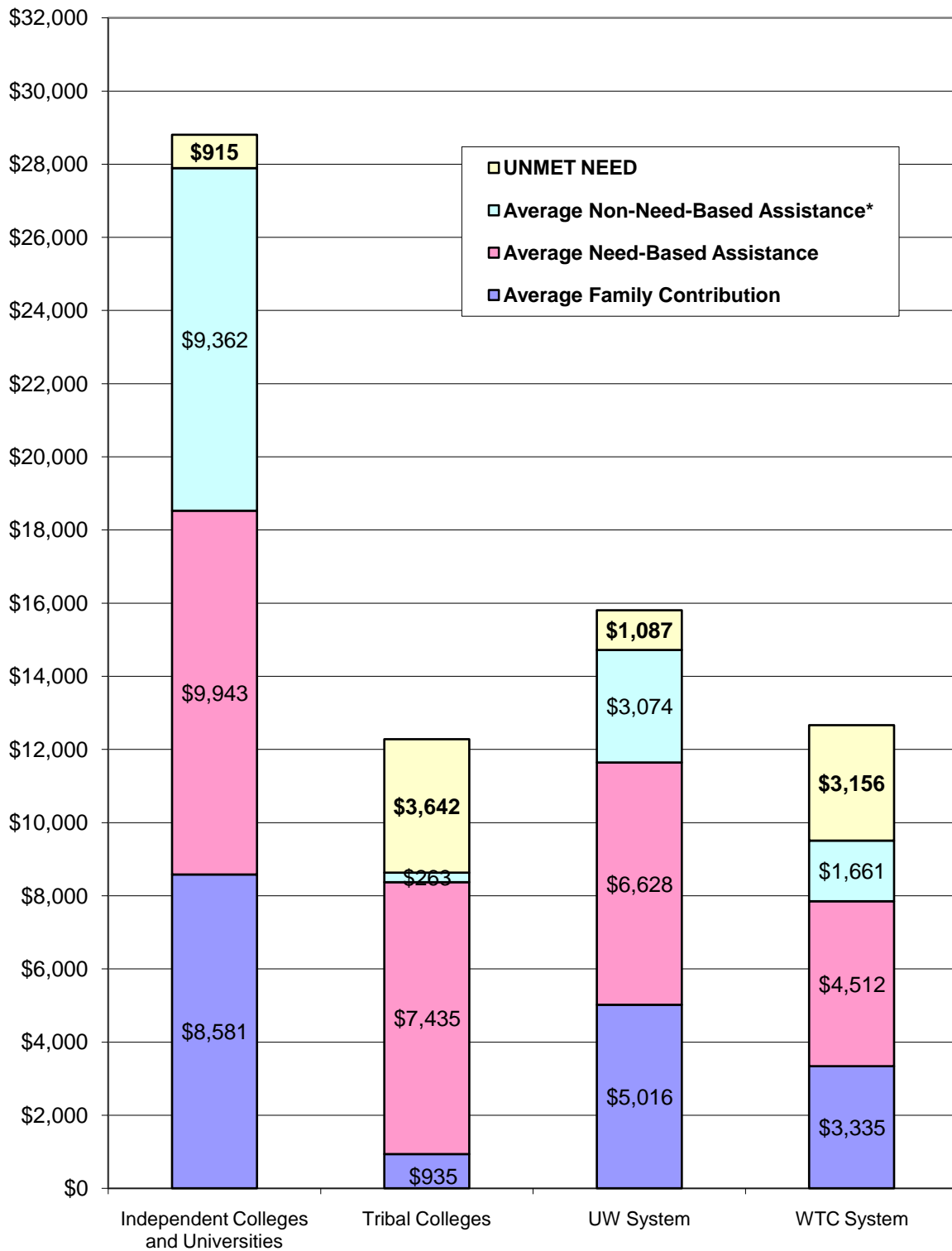
