WISCONSIN TECHNICAL EXCELLENCE SCHOLARSHIP FACT SHEET RIGHTS AND RESPONSIBILITIES OF SCHOLARSHIP RECIPIENTS 2017-2018 ACADEMIC YEAR

INTRODUCTION

This fact sheet provides information about the Technical Excellence Scholarship (TES). It details your rights and responsibilities as a recipient of the TES. Reading, understanding, and referencing this sheet as you progress through technical college will help to ensure that you receive the TES for each semester in which you are eligible. It will also ensure that you are aware of when you are not eligible for your TES, and of when your eligibility ceases permanently.

YOU SHOULD READ THIS SHEET NOW AND KEEP IT FOR FUTURE REFERENCE

THE SCHOLARSHIP

The TES provides up to \$2250 to be paid towards tuition each year for up to three years (6 semesters). The State of Wisconsin Higher Educational Aids Board pays one half of the \$2250 and the college or university pays the other half from its own funds. Each semester \$1125 is applied directly to tuition; it is not sent to the student. In rare instances when state, federal and institutional need-based assistance cover most of the cost of education, the TES may not be fully awarded.

ENROLLMENT

To receive TES, you must be enrolled in a technical program by September 30, 2017 at a participating Wisconsin Technical College to be eligible (you can select from a list of participating schools on the online acceptance form). Institutions in the Wisconsin Technical College system participate in the TES program. **If you are not enrolled** in an associate degree, diploma program or certificate program at a participating technical college by September 30, 2017, **your scholarship is automatically forfeited and will be awarded to the next qualified alternate.** If your intention is to enroll, but circumstances prevent it, please contact us.

If you transfer from one participating institution to another, you must notify the Higher Educational Aids Board in a letter or in an e-mail. Please include your name, the name of the institution *from* which you are transferring, the name of the institution *to* which you are transferring, and the semester or term in which the transfer takes effect. The Higher Educational Aids Board will notify the school to which you are transferring that you are receiving the TES. You, too, should notify both financial aid offices so that their files are updated to show your enrollment and TES status.

Eligibility for the TES ceases at the end of six semesters. You may receive the TES for no more than six consecutive semesters total, even if you have not graduated by the end of six semesters. In order to actually receive the TES funds in a given semester, you must be enrolled in that semester in a degree, diploma or certificate program. To retain continuing eligibility for the TES, you must be enrolled each consecutive semester. If you are not enrolled each consecutive semester, you risk losing the TES permanently as well as in the given semester. You may use TES for more than one program.

If you do not enroll at all in a given semester, or if you enroll but drop courses you must contact the Higher Educational Aids Board before doing so. Not enrolling could adversely affect your continuing eligibility for the AES.

CONTINUING SCHOLAR ELIGIBILITY

- (1) In July of each year, the Higher Educational Aids Board will notify any scholars who have lost scholarship eligibility for the following academic year, due to insufficient credits or grade point average. Students who have met the following requirements may assume they are eligible for the following academic year.
- (2) To receive a TES for a second year, you shall have achieved a 3.000 cumulative grade point average based on a 4.000 system. You must have participated in a degree, diploma, or certificate program in what they consider to be full time.
- (3) To receive a TES for a third year, you shall have achieved a 3.000 cumulative grade point average based on a 4.000 system. You must have participated in a degree, diploma, or certificate program in what they consider to be full time.
- (4) The Higher Educational Aids Board shall pay to the institution, on your behalf, the award for the first or second semester attendance. Awards shall not be made for summer terms or other special terms of attendance.
- (6) You must be enrolled in a Wisconsin Technical College to maintain continuing eligibility. Exceptions, such as for a medical reason, military service, religious mission, or unique educational opportunity, will be considered by the Higher Educational Aids Board on a case by case basis. You should contact the Higher Educational Aids Board directly if an exception is needed. You shall be able to regain eligibility through consecutive term enrollment, including summer session and/or your cumulative grade point average to the cumulative minimum of 3.000.
