# **Report: Staff Updates**

NC-SARA Policy Modification Process - Paige Smith

Paige Smith provided an update on the NC-SARA Policy Modification Process (PMP) for 2025. This is the second year of the PMP. For 2025, there were 32 policy proposals received which involved issues, including student consumer protections increased reporting and transparency, eligibility requirements, membership term for states, and federal financial composite scores. The PMP cycle will be completed by the end of summer with proposals submitted to NC-SARA at their October 2025 board meeting.

The annual data reporting cycle is underway, running between May 15-June 15, 2025.

## Federal Regulatory Updates - Paige Smith

Paige Smith provided an update on recent federal administrative changes, including a recent Executive Order issued by President Trump related to accreditation and the U.S. Department of Education's announcement of its intention to establish a negotiated rulemaking committee which would be charged with reviewing the following areas: Refining definitions of a qualifying employer for the purposes of determining eligibility for the Public Service Loan Forgiveness program; Pay As You Earn (PAYE) and Income Contingent Repayment (ICR) repayment plans; and topics that would streamline current federal student financial assistance program regulations while maintaining or improving program integrity and institutional quality. Paige noted that the DLAB staff representatives will continue to monitor these activities.

President Rothman asked whether distance education will be impacted by the proposed federal changes regarding institution responsibility to repay the federal government for a student's financial aid upon default. Paige responded that it will likely be consistent with non-distance education programs, depending on the number of students receiving financial aid as part of their tuition payment.

Finally, Paige mentioned that NC-SARA is also tracking state legislative activities related to enforcement of state laws that would impact or conflict with existing SARA policies. If more states begin to enforce their consumer protection laws against institutions, it will have an impact on their SARA membership and institution participation.

Complaints Report - Paige Smith

On behalf of DSPS, Paige Smith reported no complaints for this quarter. Kudos given to Joan Gage for tracking and maintaining the complaint process.
