STATUS OF 2008-09 AND 2009-10 APPLICANTS AND PROGRAMS

2009-2010

Wisconsin Higher Education Grant - UW WHEG - UW committed 126.09% (\$69,349,582) of its appropriation with 29,189 awards. This is 3,966 more awards and 22.53% more committed than at this time last year. In 2008-09 the program had committed 103.56% of its appropriation at this time. HEAB has received 7,922 more applicants than at this time last year. The final commitment for 2008-09 was 131.99%. (W & Z codes were applied July 3, 2009)

Wisconsin Higher Education Grant - WTC WHEG - WTC committed 160.64% (\$28,145,519) of its appropriation with 26,734 awards. This is 2,391 more awards and 29.04% more committed than at this time last year. In 2008-09 the program had committed 131.60% of its appropriation at this time. HEAB has received 12,152 more applicants than at this time last year. The final commitment for 2008-09 was 170.05%. (W & Z codes were applied June 4, 2009)

Wisconsin Tuition Grant

WTG has committed 127.97% (\$33,705,829) of its appropriation with 11,988 awards. This is 349 more awards and 3.11% more committed than at this time last year. In 2008-09 the program had committed 124.86% of its appropriation at this time. The final commitment for 2008-09 was 118.86%. W codes were applied on June 3rd, 2009.

Wisconsin Higher Education Grant - Tribal

WHEG - Tribal has committed 139.47% (\$612,033) of its appropriation with 367 awards. This is 73 fewer awards and 21.48% less committed than at this time last year. In 2008-09 the program had committed 160.95 % of its appropriation at this time. The final commitment for 2008-09 was 313.13%. W codes were applied on June 3rd, 2009.

Status of Applicants

The total number of applicants (first-time FAFSA filers who listed Wisconsin as their state of legal residence) for 2009-10, through July 27, 2009, is 245,273. Applicants for 2008-09 totaled 273,830.

Wisconsin Higher Education Grant – UW WHEG - UW has committed 131.99% (\$72,591,841) of its appropriation with 32,001 awards. This is 834 more awards and 1.11% less committed than at this time last year. In 2007-08 the program had committed 133.10% of its appropriation at this time. (W & Z codes applied December 3, 2008)

Wisconsin Higher Education Grant – WTC WHEG – WTC has committed 170.05% (\$30,221,085) of its appropriation with 31,471 awards. This is 2,555 fewer awards and 2.82% less committed than at this time last year. In 2007-08 the program had committed 172.87% of its appropriation at this time. (W & Z codes applied August 21, 2008)

Wisconsin Tuition Grant

WTG has committed 118.86% (\$31,622,967) of its appropriation with 11,576 awards. This is 1,429 more awards and 4.94% more committed than at this time last year. In 2007-08 the program had committed 113.92% of its appropriation at this time.

Wisconsin Higher Education Grant – Tribal WHEG – Tribal has committed 313.13% (\$1,344,739) of its appropriation with 881 awards. This is 597 more awards and 216.04% more committed than at this time last year. In 2007-08 the program had committed 97.09% of its appropriation at this time.

Status of Applicants

The number of applicants (first-time FAFSA filers who listed Wisconsin as their state of legal residence) for 2008-09, through July 30, 2008, is 208,039. Last year at this time there were 193,477 applicants. Applicants for 2007-08 totaled 262,773.
