**2009-10 APPLICANTS AND PROGRAMS**

**Wisconsin Higher Education Grant – UW WHEG** - UW has committed 125.58% (\$69,071,146) of its appropriation with 29,087 awards. This is 2,786 fewer awards and 5.98% less committed than at this time last year. In 2008-09 the program had committed 131.56% of its appropriation at this time. (W and Z codes were applied 7/2/09 for the 0910 academic year and 12/3/08 for the 0809 academic year.)

**Wisconsin Higher Education Grant – WTC**

WHEG – WTC has committed 155.37% (\$27,826,891) of its appropriation with 26,450 awards. This is 5,033 fewer awards and 14.46% less committed than at this time last year. In 2008-09 the program had committed 169.83% of its appropriation at this time. (W and Z codes were applied 6/4/9 for the 0910 academic year and 8/21/08 for the 0809 academic year.)

**Wisconsin Tuition Grant**

WTG has committed 134.43% (\$35,405,706) of its appropriation with 12,699 awards. This is 1802 more awards and 24.77% more committed than at this time last year. In 2008-09 the program had committed 109.66% of its appropriation at this time.

**Wisconsin Higher Education Grant – Tribal**

WHEG – Tribal has committed 128.40% (\$438,800) of its appropriation with 340 awards. This is 83 less awards and 2.20% more committed than at this time last year. In 2008-09 the program had committed 127.20% of its appropriation at this time.

**Status of Applicants**

The number of applicants (first-time FAFSA filers who listed Wisconsin as their state of legal residence) for 2009-10, through February 16, 2009, is 332,448. Last year at this time there were 267,921 applicants. Applicants for 2008-09 totaled 273,830.
