Dear Chair Bode and Executive Secretary DeVooght,

As directed by Wisconsin statute, we are submitting the Wisconsin Association of Independent Colleges and Universities (WAICU) recommendation for the Wisconsin Grant funding formula for low-income Wisconsin students attending private, nonprofit colleges and universities.

WAICU's goal in recommending the formula components continues to be in alignment with WAICU's mission: "working together for educational opportunity." While WAICU institutions do not receive operating dollars from the state as do public institutions, our low-income students do receive support through the Wisconsin Grant which is the primary state-funded, need-based financial aid program for Wisconsin students attending private, nonprofit colleges and universities.

Wisconsin Grants are a proven, cost-effective vehicle for expanding opportunity. By providing state grant aid and targeting those who, without help, could not attend a college or university, Wisconsin will expand its qualified workforce. Additionally, state appropriations for need-based aid also help ensure that low-income students who do enroll in college emerge with an on-time degree and manageable debt levels.

WAICU remains focused on prioritizing our lowest income students. Given this, we are recommending a formula that will maintain the maximum grant at \$4,850 for our lowest income students while reducing funding in the additional Student Aid Index (SAI) eligibility tiers of our formula. We are also recommending an additional tier of funding that can be implemented, only if sufficient funding is available. Please see our formula recommendation attached to this letter.

WAICU is committed to the public-private partnership between member institutions and the State of Wisconsin. In addition to the state and federal aid low-income students may receive, WAICU members support students by:

- Raising funds. Ninety-five percent of grant aid distributed to students enrolled in Wisconsin private, nonprofit colleges or universities are private funds raised/provided by the institutions themselves.

- Educating more than 52,000 students each year and graduating 23 percent of the state's bachelor's degrees and 33 percent of the state's graduate degrees.

Investments in state aid also serve as an incentive for students to remain in Wisconsin for college. While WAICU is grateful for the recent increase in our appropriation, we remain hopeful there will be continued investments in the Wisconsin Grant Private Nonprofit appropriation, given Wisconsin continues to rank last among our Great Lakes counterparts in need-based aid for students in our sector. WAICU will continue to advocate for increased support for this critical program.

We extend our thanks to the Higher Educational Aids Board (HEAB) staff, specifically Sherrie Nelson and Joy Dyer, for working with WAICU members and WAICU staff, particularly given the complexities of moving from the old main frame system to the new Grants, Loans and Student Scholarships (GLASS) System.

WAICU is hopeful that, going forward, fully implementing the GLASS System will make it possible for HEAB to better project appropriation spending and to share with schools an expected waitlist period that will enable institutions to effectively communicate that information with students. Given this uncertainty with appropriation spending, WAICU reserves the right to recommend modifications in the formula, particularly if new information becomes available and/or if additional funds are allocated for the Wisconsin Grant.
