I am pleased to submit the Wisconsin Technical College System's (WTCS) recommendation for the 2026-27 Wisconsin Grant awards.

For 2026-27, WTCS recommends a maximum Wisconsin Grants award of \$1,752 for eligible WTCS students. Additionally, we propose a second-tier award of \$500 for students with an expected family contribution between \$6,693 and \$8,000, contingent upon the availability of additional funds. This approach ensures that all enrolled and eligible students receive meaningful financial support, helping to reduce student debt and accelerate credential completion. These recommended award levels remain unchanged from the previous academic year.
